# STUDENT WELLBEING & MANAGEMENT POLICY

## Purpose

The purpose of this policy is to provide students, staff members, paændsguardians with clarity as to the behaviour expected of students at the College and the consequences when those expectations are breached.

Schoolwide expectations encourage consistent communications and establish an effective community for all staff and students and across ouollege



## Bullying

Bullying is an ongoing or repeated misuse of power in relationships, with the intention to cause deliberate harm. There are four types of bully (ngrbal, physical, social and cyber bullying) escare defined as below:

Verbal Bullying

Any student who arrives at school after 8.35am must report to the Office and sign in. Consistent lateness will be followed up.

If a student is more than 10 minutes late to any lesson (without valid reason), the teacher will record the student as absent and inform the Year Level Coordinator should it happen again. Students cannot leave the school grounds for any reason without the the permission of the Year Level Coordinator. Recurring lateness and absences from classes will be dealt with by the Year Level Coordinator and the relevant Head of School.

#### Leaving School Grounds

The school shares with parents and students ponsibility for student safety and conduct. Therefore, if it is necessary for a student to leave school during a school day, they must bring a note farm tor guardian for the schooland be picked up

Once students leave schoordounds, they cannot reenter the school grounds unless a prior arrangement has been made in consultation with the school and a parent/guardian

#### Truancy

If students deliberatelyskip classes, they will be suspended

Detention: teachers may require a student to complete ool workor additional work or duties at recess or lunch break, or afterschool.
